Each restricted stock unit represents a right to receive one share of the Registrant's common stock.
- Represents (i) 25,400 shares of common stock, (ii) 10,000 restricted stock units previously granted to the Reporting Person on March 18, 2010 and (iii) 10,000 restricted stock units granted to the Reporting Person on January 3, 2011 which will vest as set forth in note 1.
